INKWRX technology will be used to launch RamQuest's own Inx digital pen solution which is tailored to automate the digitization of forms necessary to consummate the mortgage and settlement aspects of a real estate transaction. RamQuest's title production software is used to facilitate approximately 2 million real estate closings per year and will use the technology in a 10-year agreement to market the Inx solution to more than 30,000 title and settlement agents Nationwide in the US.

The implementation of the INKWRX technology will take 6 months.
