

Alm. Brand – ugentlig rapportering om aktietilbagekøb

Alm. Brand har i perioden 18. juli til den 22. juli 2016 købt egne aktier for samlet 5,4 mio.kr. Dette er sket som led i det forhøjede aktietilbagekøbsprogram på op til 400 mio.kr., som blev annonceret den 26. april 2016. Samlet er der tilbagekøbt aktier for 201,2 mio.kr. svarende til 50,3 % af det samlede program.
